Per Louisiana Pollutant Discharge Elimination System (LPDES) Permit LA0062600, Cleco Power LLC (Cleco) is submitting one original and one copy of the annual progress report required by Section AA of the facility's LPDES permit, per 40 CFR 423.19(g). This progress report is representative of activities that have occurred between August 1, 2023, and July 31, 2024.


Prior to the issuance of the most recent LPDES permit, Cleco submitted a Notice of Planned Participation (NOPP) per 40 CFR 423.19(g) to comply with the Effluent Guidelines and Standards for Steam Electric Power Generating Point Source Category (ELG rule). As indicated by the NOPP, Cleco intends to comply with the ELG rule by ceasing coal fired operation by no later than December 31, 2028.

As of December 31, 2021, the Dolet Hills Power Station has ceased coal fired operation and decommissioning/demolition activities have begun. In the time period covered by this progress report, Cleco completed the closure by removal activities associated with the bottom ash basins, in accordance with the facility's LDEQ approved closure plans. Closure certification requests will be submitted in the coming months.

It is Cleco's understanding that the information above satisfies the requirements of section AA of the LPDES Permit Other Conditions Section. Given that the facility has ceased coal fired operation, this will be the final progress report related to the NOPP. In accordance with 40 CFR 423.19(g)(4)(iv),
